Reminders about the 2022 election changes:

Early Voting: Voters can cast a ballot in-person nine days prior to election day

Schedule: Beginning the 11th day before election day through the 2nd day before election day.

Time: Early Voting is 8:30 am to 4:30 pm daily except Thursday hours are noon to 8 pm.

Locations: Highland Township Office, 205 N. John St or Regional site at Waterford Oaks Activity Center, 2800 Watkins Lake Road, Waterford.

Permanent Mail Ballot List

Voters can sign up to be on the Permanent Mail Ballot List to automatically receive an absentee ballot by mail for every future election. Those who travel often might prefer the automatic application list instead.
