- 1. Include **building permit number** if there is one, address & job description/items.
- 2. Enclose a copy of contractor's license every time.
- 3. Enclose a copy of contractor's driver license every time.
- 4. Contractor must sign and date application; if <u>an agent is pulling</u> the permit <u>on behalf of</u> the licensed <u>contractor a notarized letter</u> on company letterhead <u>giving permission</u> to the agent <u>must be submitted</u>.
- 5. Always indicate the number of inspections you need.
- 6. Each application Must be filled out completely.

We need one copy with the above information for <u>each and every application</u> – filled out in full.
